FROM THE SUPERVISOR

As winter leaves us and spring arrives the constant questions asked are about road conditions and brining. The township board is 100% behind the improvement of our roads. We believe it is a vital part of serving those that have elected us to govern. The township road committee that works with the Newaygo County Road Commission has recommended approximately \$268,000 to improve and brine our roads in 2016. These projects are important to keep all roads safe. The board is happy to support this type of improvement to make our roads an example of excellence. The past 3 years we have spent an average of \$200,000 on road improvements. That money has come out of our general fund. To be fiscally responsible the township must maintain a balance of approximately one year's budget in its general fund. In order to continue to budget this money the township feels that a road millage will be needed in the near future. This is the only way we will be able to continue to fund road infrastructure. The board would continue to budget general fund money along with money generated by a road millage. The township board will be discussing the possibility of asking for a road millage in the future months. Information will be in future newsletters and on our website. The board is interested in all questions and concerns regarding this issue.

The township is continuing its participation in the River Watch program. Working together with citizens, the County Sheriff and DNR officials this program has been a great success. If you would like to get involved with this program please contact the township.

Recycling for Newaygo County is beginning their 2nd year located here at the township. They continue to do a great job and we encourage everyone to participate in recycling.

The township will be funding a part-time deputy from the Sheriff's department for extra patrols during some weekends this summer. Residents have expressed concern with safety during these times and we felt this was an important issue.

Dates for brining our gravel roads are tentatively scheduled for May 23, June 27 and August 29. With the unpredictability of weather and conditions these dates may change. We will again be using D&B Brine.

There are many good things happening around the township and the township board encourages everyone to get involved. As always if you have any questions regarding any of the above issues or anything else please contact any township official.

BROOKS TOWNSHIP ZONING DEPARTMENT

There have been a few changes in the Brooks Township Zoning Ordinances in the past year. After much consideration a change was made to the minimum square footage for a new residence. It was lowered from 1200 sq. ft. to 864 sq. ft. The minimum width of 24 ft. for a residence was not changed. Changes were also made for Home Occupation signs and in the Lakefront District (LD) regarding decks. These changes are located on our website under publications.

REMINDERS:

- Temporary camping permits are required to camp for more than four (4) non-consecutive or consecutive nights in a thirty (30) day period. There is no fee for the permit and it can be found on our website.
- Any dumping of leaves and other yard waste on federal land or other person's property is a violation of the township ordinance.
- There is a twenty-five (25) foot Green Belt area around all lakes. This area is to be left in its natural vegetative state. Prior to removing or constructing anything within this area please contact the zoning administrator.
- If you are considering construction of any kind please make sure you check with the township to see if a permit is required. Any construction or placing of buildings larger than 200 sq. ft. require a permit.
