Public Hearing -

The Hearing proposal was properly posted in the Times Indicator and copies were mailed to individuals residing within 300 feet of the property.

Chairman Guzniczak opened the hearing at 7:04, for the North Shore Restaurant Site Plan and Special Land Use Application. He explained the purpose of testimony and time limitations for those who provided testimony.

The applicant/developers Nate Thompson and Raeanne Huskey presented details of the site plan and project detail. Planning Commission Members questions were addressed.

Joe Selzer presented the Staff Report for the application filed 1/18/22, and reviewed each standard noting that all setback requirements, standards for site plan review, and standards for approval have been met for the restaurant. He recommended approval of the Site Plan with the condition that the proposed parking lot be screened per Section 18.04 A. Additionally, he recommended approval of the Special Land Use Application with the following three conditions:

- 1) A 10% performance guarantee be provided by the applicant
- 2) The fueling station and tank not be installed
- 3) Sign face for ground signs be submitted prior to installation
