**Coolbough Management Commission** – Badgero reported there is now direct access to the horse trail from the parking lot between the pavilion and Hazelwood. Additionally, a new person has been assigned from the Michigan Association, and Vivian Miller will be replacing Chris Haynor as a board member.

**Chain of Lakes Sewer Authority** – Nelson reported the quarterly meeting was held last week. A highlight of the meeting was the presentation of a “substance” which contained a mass of flushable wipes that had been taken from a clogged sewer line. The use of these wipes is strongly discouraged due to the damage and expense to the COLA sewer lines.

**Newaygo Area Recreation Authority** – Badgero reported that the disc golf course should be completed soon. The dugouts on Centerline need new roofs. Bids are being secured for roofs and possibly sidewalls.
